## ORDER

As per the Government Order read as 1 st paper above, No Objection Certificate was issued to Educare Institute of Dental Sciences, Kiliyamannil Campus, Chittiparamba, Malappuram, for conducting Diploma Course in Dental Mechanic (DCDM) Course. Now as per letter read as 3<sup>rd</sup> paper above, the institution, after complying with the conditions stipulated in the No Objection Certificate, has requested to issue a Letter of Permission for the course with 10 seats.

Government have examined the matter in detail and are pleased to grant Letter of Permission to Educare Institute of Dental Sciences, Kiliyamannil Campus, Chittiparamba, Malappuram, to start Diploma Course in Dental Mechanic (DCDM) with 10 seats on the conditions that the institution;

a. shall agree to admit students on 50% merit and 50% management basis. Merit seat students shall be admitted from the respective State merit list prepared by the Director of Medical Education/Director, LBS Centre and management seats by the Management based on merit,

b. shall adhere to fees fixed by the Government from time to time, and no

amount other than that fixed by the Government shall be levied from the students admitted to the aforesaid courses,

c. shall agree to comply with all conditions specified in the prospectus issued

by the Director of Medical Education for each year,

d. shall execute an agreement with the Health and Family Welfare (K) Department in respect of fees and admissions every year before the allotment of students to the Government merit seats and commencement of classes in an academic year and shall adhere to all conditions contained in that agreement,

e. shall produce a Bank Guarantee for an amount of Rs. 5 Lakhs for the course, valid for two years, immediately after issuance of the Letter of

Permission,

f. shall renew the Bank Guarantee before its expiry,

g. the Letter of Permission will be withdrawn if any of the above conditions are violated, and

h. shall obtain the permission of the State Allied Health and Healthcare Council as and when it becomes functional.
