Admission to the Government Colleges and 50% Government seats of self-financing colleges is limited to Indian citizens of Kerala origin and those who have studied/are studying in educational institutions of Kerala from class VIII to XII will also be treated on a par with Indian citizens for admission to the course.

The Managing Director, Educare Institute of Dental Sciences, Chattiparamba, Malappuram, Kerala has applied for Essentiality Certificate for starting Post Graduate Dental Courses in the specialities of Orthodontics and Prosthodontics. On careful consideration of the proposal, the Government of Kerala has decided to issue an Essentiality Certificate for the same with 3 seats in each specialty. It shall be the duty of the applicant to produce evidence that the infrastructural facilities such as teaching, preclinical, para clinical and allied Dental sciences, are owned by the Dental College. The Institution will execute a consensual agreement with the Government to share 50% of seats.

The Essentiality Certificate is valid for the academic year 2016-17 onwards
