### ADMISSION POLICY

### BDS ADMISSION

No candidate shall be allowed to be admitted to the medical curriculum of first Bachelor of Dental Surgery (BDS) course until:

- a. He/She has completed the age of 17 years on or before the 31st of December of the year commencing the prescribed academic session of the said course.
  - b. He/ She has passed qualifying examination as under:
- c. A candidate who has passed Higher Secondary examination of the Board of Higher Secondary Education, Kerala, or Examinations recognized equivalent there to by KUHS with 50% mark in Biology/Biotechnology separately and 50% marks in Physics, Chemistry and Biology/Biotechnology put together are eligible. The candidate must study English as a subject in the Higher Secondary course In respect of candidates belonging to Socially & Educationally Backward Classes the minimum marks required in qualifying examination in Physics, Chemistry and Biology/Biotechnology taken together and in Biology/Biotechnology separately is relaxed to 45% instead of 50% as above.

With respect to candidates belonging to Scheduled Castes and Schedules Tribes the minimum marks required in qualifying examination in Physics, Chemistry and Biology/Biotechnology taken together is relaxed to 40%. The eligibility criteria for admission to persons with disability of lower limbs (40 to 70%)— will be a minimum of 45% marks instead of 50% taken together in qualifying examination and competitive entrance examination for admission in BDS course or any other examination which, in scope and standard is found to be

equivalent to the intermediate science examination of an Indian University/ Board, taking Physics, Chemistry and Biology/Biotechnology including practical test in each of these subjects and English.

#### NATIONALITY:

Candidates must be Citizens of India / children or dependents of Non Resident Indians. Persons of Indian Origin (PIO)/ Overseas Citizen of India [OCI] will also be treated at par with Indian citizens for the limited purpose of admission. However JPIQ/OCI candidates will not be eligible for any kind of reservation.

#### AGE

Applicants shall complete the age of 17 years on 31st December of the admission year.

### ACADEMIC:

As per the 'Dental Council of India BDS Course Regulation 2007', the applicant should have passed the qualifying examinations as under:

(a)The Higher Secondary Examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher Secondary Examination after a period of 12 years study, the last two years of study comprising of Physics, Chemistry, Biology, and Mathematics or any other elective subjects with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training after the introduction of the 10+2+3 years educational structure as recommended by the National Committee on education or a pass in plus two under the CBSE stream of syllabus.

Note: Where the course content is not as prescribed for 10+2 education structure of the National Committee, the candidates will have to undergo a period of one year pre-professional training

The Intermediate examination in science of an Indian University/Board or other recognized examining body with Physics, Chemistry and Biology which shall include a practical test in these subjects and also English as a compulsory subject.

Or

The pre-professional/pre-medical examination with Physics, Chemistry and Biology, after passing either the higher secondary school examination, or the pre-university or an equivalent examination. The pre- professional/premedical examination shall include a practical test in Physics, Chemistry & Biology and also English as a compulsory subject.

The first year of the three years degree course of a recognized university, with Physics, Chemistry and Biology including a practical test in these subjects provided the examination is a "University Examination" and candidate has passed 10+2 with English at a level not less than a core course.

B.Sc examination of an Indian University, provided that he/she has passed the B.Sc examination with mot less than two of the following subjects Physics, Chemistry, Biology (Botany, Zoology) and further that he/she has passed the earlier qualifying examination with the following subjects - Physics, Chemistry, Biology and English.

Any other examination which, in scope and standard is found to be equivalent to the Intermediate

Note:

The pre-medical course may be conducted either at a Dental College or a Science College.

Marks obtained in mathematics are not to be considered for admission to BDS course

After the 10+2 course is introduced, the integrated courses should be abolished.

Rounding off of the percentage of marks to the nearest whole number is not permitted.

Candidates who have not passed their qualifying exam from the Kerala Higher Secondary Board, the CBSE or the ICSE shall provide an equivalency certificate obtained from KUHS.

# I. CRITERIA FOR ADMISSION & SELECTION PROCESS

Selection of Students will be only on the basis of inter-se-merit. They should be eligible for admission on the basis of National Eligibility cum Entrance Test. For open merit candidate, they should have obtained the 50 % marks in the qualifying exam for the core subjects. Candidates belonging to SC/ST/SEBC will be considered for admission to this course only if they have scored a minimum of 40% marks in the National Entrance Examination. Candidates with Loco motor disability of lower limbs between 40% to 70% will be considered for admission to BDS course only if they have scored a minimum of 45% marks in the National Entrance Examination.

Relaxation of marks in qualifying examination: Candidates belonging to Socially and Educationally Backward Classes (as per G.O. (P) No. 208/66/Edn dated 2.5.1966 and amendments thereof), with a total annual family income not exceeding Rs. 6 lakhs, will have a relaxation of 5% marks in the qualifying examination.

They need only 45% marks in the case of biology and 45% marks in the case of Biology, Physics and Chemistry put together. Candidates belonging to SC/ST categories need 40% marks in Physics, Chemistry and Biology put together in the qualifying examination. The SEBC candidates should submit their Community Certificate and Non creamy layer Certificate in the prescribed format and their income certificate obtained from the concerned authority. Candidates who have registered in KEAM alone will be considered for admission. The NEET qualified candidates, should upload their NEET score and rank in the website of CEE using their KEAM registration credentials.

Selection to BDS course is made by the Controller of Entrance Examination (CEE), Kerala based on inter-se-merit from the Kerala NEET rank list including for the NRI seats. Selection will be done by CEE through a centralized counseling and allotment process. The vacancies if any after first and second allotment will be filled up by CEE through spot admission as per norms.

# IV. ADMISSION TO THE MINORITY QUOTA SEATS

These candidates are given online facilities to exercise their option in the candidates' portal of CEE website and based on the rank list, CEE will allot seats based on their merit to the colleges as per the option of the candidates.

### Academic:

- Applicant should have passed BDS degree from any of the Universities in Kerala or from any other University recognized by any of the Universities in Kerala as equivalent to.
- ii. Registration with the State Dental Council.

#### Note

The candidates can give all possible options in the preferences form issued along with the application form. Options once furnished will be final. Allotment of candidates to the MDS courses shall be made on the basis of the rank obtained in the entrance examination and depending on the availability of seats. If a candidate gets selected for the first option he/she will not be considered for the lower options. If a candidate gets selected for his/her lower option the day of Counselling, he/she will be considered for the higher options as per rank, if vacancy arises on or before on the last date of counselling in that particular subject, provided he/she has joined and is continuing the course of his/her lower option.

No candidate shall be permitted to do post graduate course in more than one specialty simultaneously. One should have completed or discontinued the course before joining post graduate course in a different specialty.

# Date of Joining and transfer

- a) It is mandatory for the candidate to join the course on the date fixed at the time of counseling, if selected.
- b)If a candidate does not join the course to which he/she is selected or discontinues the course after joining, his/her claim for admission for the higher option shall be forfeited.
